In continuation of this Board's earlier Result Notice No.47 dated 27/07/2016; Result Notice No.95 dated 19/10/2016; Result Notice No.118 dated 21/02/2017; Result Notice No.136 dated 11.05.2017; Result Notice No.156 dated 30/06/2017 and Result Notice No.172 dated 16.08.2017 the candidate having **Roll No.54100871** is also provisionally nominated under OBC category on the basis of written examination held on 28/12/2014 and found provisionally eligible as per documents submitted in support of educational qualification, age, etc., in accordance with advertisement No.01/2013 and RRs for the post of TGT Social Science (Male), Post Code-12/13 in Directorate of Education. The candidature of this candidate was kept pending for verification of OBC (Delhi) status from the Revenue Department. The provisional nomination of the candidate is being made now after receipt of necessary clarification regarding his OBC (Delhi) status from the concerned Revenue Authority.

The selection of the above candidate shall further be subject to genuineness of the documents on the basis of which he claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photograph, signature/handwriting etc., on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after satisfying themselves of his eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Caste Certificate and other certificates, if any, seeking any relaxation in the eligibility standards. While getting the Caste Certificate verified from the Issuing authority, it should be invariably ensured that the candidates claiming benefit under OBC category do not fall under creamy layer as per the latest instructions of the Govt. of India in this regard. It is further clarified that the eligibility regarding knowledge of Hindi/working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and the same, therefore, should be ensured by the User Department before issuance of appointment letter.

Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.


