**CORRIGENDUM**

In partial modification of Office memorandum regarding improvement in Delhi Government Employees health Scheme (DGEHS) No. F 25(111)/DGEHS/140/DHS/09/38850-862 dated 28.7.10 clause No. 5.1. II, 5.2.3 and 7.3 of the office memorandum may be read as:-

5.1. II - Sitting MLAs as well as Ex MLAs of Delhi Legislative Assembly.

5.3 Besides, Ministers of GNCT of Delhi and sitting MLAs, the Ex. MLAs of Delhi Legislative Assembly shall also be allowed treatment on cashless basis in empanelled private hospitals/diagnostic centers. The payment to empanelled hospitals /diagnostic centers for such cashless treatment shall continue to be made by GAD in case of Ministers and Delhi legislative Assembly in case sitting MLAs as well as Ex MLAs.

7.3 To allow treatment in NCR region also for beneficiaries residing in Delhi also after Permission from competent authority.

Since clause no. 6 has already been covered in clause no. 5 therefore clause No. 6 stands deleted.

Rest of the clauses remain unchanged.
