GENERAL INSTRUCTIONS FOR CANDIDATES FOR THE POST OF MATRON (FEMALE), POST CODE 85/17 IN DELHI PRISONS DEPARTMENT

NO ENTRY WILL BE ALLOWED AFTER REPORTING TIME MENTIONED AT E-ADMIT CARD. LATE COMER WILL BE TREATED AS ABSENT.

1. Candidates should bring E-admit card along with I.D. proof (in original) and photocopy of each.
2. The candidate has to also bring 2nd page of e-admit card on which colored postcard Size (4"x6") photograph displaying only face and shoulder in the designed space be pasted otherwise he/she would not be allowed to take part in the Test.
3. The candidate has to sign across the photograph on left side and put his/her Left Thumb impression in the designed space as given in the 2nd page of e-admit card before Assistant Observer at Test Venue.
4. The candidate should bring his/her original as well as one photo copy of Caste Certificate for seeking relaxation in Physical measurement as per the provisions in RRs.
5. The Test/Exam will be conducted at Sports Complex, East Vinod Nagar (Mayur Vihar Phase- II) near Neelam Mata Mandir, Delhi – 110091. The date and reporting time at the Test Centre shall be mentioned on e-admit card.
6. E-admit cards has been uploaded on the official web site of DSSSB i.e. dsssonline.nic.in and eligible candidates may download their e-admit card w.e.f. 29.11.2018 (11:59 PM). In case, any candidate finds difficulties in downloading the e-admit card he/she may contact the Board office on Telephone No. 22379204/22370307 or may approach the DSSSB office at FC – 18, Institutional Area, Karkardooma, Delhi – 110092 on 05.12.2018 between 10:00AM to 5:00PM alongwith proof of their identity (Voter ID Card, Aadhar Card, Govt. ID Card, Driving Licence).
7. Any kind of Malpractice such as impersonation, canvassing, usage of steroids etc. Shall invite penal action including rejection from present test as well as debarring from future examinations / tests.
8. The candidature of the candidates allowed by the court for Physical Endurance Test is entirely provisional and subject to the outcome of directions / decisions / orders pronouncement of any Court of Law and mere issue of admit card or appearance at the Test does not entitle the candidates to any claim for the post.
9. The Board reserves the right to cancel a part of our entire process of Test due to administrative reasons and in case of unfair means, cheating or other irregularities / malpractices if noticed by the Board. The Board also reserves the right to cancel Test Centre or set up a new centre and divert the candidates to appear at new

centre, if required. No request for change in date, time and centre of Test will be accepted under any circumstance.

10. The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment / selection.
11. No TA/DA is admissible to any candidate for appearing in the test.
12. All candidates are strictly advised to wear vest/T-shirt for affixing chest badge for clear identification during Physical Endurance Test (PET).
13. The Candidate should scrupulously follow these instructions and also that of the designated officers of the Board at the Test Centre failing which the candidature of the candidate may be cancelled.
