

CIRCULAR

In reference to court case in HIGH COURT OF DELHI W P (C) No. 1346/15, regarding air pollution in Delhi, where following direction dated 09/11/2017, has been issued by the Hon'ble court.

"2. All the counsels submitted that with regard to the particular air levels, which are upto 20 times beyond the hazard level, emergent steps should be addressed and taken by the concerned authorities, especially Govt. of NCT of Delhi and the local bodies/municipal authorities to ensure the following:

...iv) The authorities be directed to ensure that the hospitals are appropriately equipped to deal with emergency situations as on consequence of high level pollution specifically having regard to the vulnerability of children and senior citizens. In this regard, it is suggested that the Delhi Govt. as well as Union Govt. on urgent basis should conduct a survey in the hospitals to ensure that adequate steps are taken."

The Directorate General of Health Services (DGHS) on behalf of Department of Health & Family Welfare has sought reports from the hospitals for their preparedness to deal with emergency situations as a consequence of high level pollution especially with regard to vulnerability of children and senior citizens. The hospitals covered under the Department of Health & Family Welfare have given their response that they are well equipped.

In continuation of the same it is further directed that hospitals will constitute a three members team including doctors from medical, paediatric

specialities to access the preparedness of neighbouring hospital to assess the following parameters.

1. Availability of adequate oxygen;
 2. Availability of life saving medicines;
 3. Availability of adequate man power & beds;
 4. Preparedness of hospitals in regard to present air pollution in Delhi.
