The DSSSB vide its advertisement No 03/20143 with closing date 18/02/2014, had advertised 19 vacancies for the post of Food Safety Officer in the Department of Food Safety under Post code 45/2013. Board conducted Tier-I written examination for recruitment in respect of this post on 05.03.2017. Marks of the candidates have been uploaded on Board's website. Based on the performance in Tier-I written examination, 84 (eighty four) candidates who have obtained marks above the cutoff marks, have been provisionally shortlisted to appear in Tier-II Exam, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms.
