NOTICE

Application are invited for the post of **JUNIOR RESIDENTS (MBBS) on Regular basis for 01 (One) year** in G.T.B. Hospital, Govt. of N.C.T. of Delhi. The total vacant posts in various Departments reserved as per rosters and vacancies for UR,SC,ST, and OBC have been detailed as under:-

As per order No. 5/1593/2017-Wel/CD/251 dated 05.05.2017, issued by State Commissioner for persons with Disabilities, Differently Abled candidates will be eligible for 4 % reservation in the concerned category as per rule & there will be no application fee.

The number of vacant posts indicated above are provisional and subject to change. The eligibility, General conditions & other conditions for recruitment of Junior Resident (MBBS) is as follows:-

1. Qualification:-MBBS Degree from a recognized university/Institute approved by MCI.
2. Registration: The Candidates shall provide Delhi Medical Council Registration certificate/ Applied for receipt at the time of Joining. The applied for candidate must submit DMC registration within 45 days of Joining otherwise his/her appointment shall be cancelled.
3. Candidates who have completed internship before two year from last date Submission of application are not eligible (08. 08.2015)
4. Admissible emoluments: Pay Matrix of Level 10 (Rs 56100) and other allowances as admissible under the rules.
5. Age limit as on Last date of submission of application:-
SC/ST- 35 Years
OBC- 33 Years
General- 30 years.
Age relaxation for the SC/ST/OBC/Differently Abled candidates shall be applicable as per instructions of Govt. of India from time to time.
6. **Tenure : Initially appointment is for 6 month tenure which will be extended up to 1 Year after due recommendation by the concerned HOD.**
7. The number of post may vary as per requirement.
8. **Application Must be addressed to the Medical Director, GTB Hospital , Delhi with full Bio-Data along with the attested copies of the certificates as mentioned in point D, should be submitted in Room No. 307 till 08.08.2017 by 4 :00 pm.**



9 In case number of applications are high, the interview may be continued on the next working day. The same will be informed to the candidates verbally by Board Members on the date of interview at the closing time. Therefore, candidate who is not interviewed on the said date shall not leave the place, without the knowledge of Board Members. No separate communication will be made in this regard.

10 **The candidates who have already worked in any of the Govt. Hospitals as Junior Resident (MBBS), the total period as worked will be counted to calculate the remaining period of Junior Residency.**

11 **In case of non availability of SC/ST/OBC candidates, posts shall be filled for 89 days on adhoc basis as per combined merit.**

12 **In case of non-availability:-** of the candidates as per the aforesaid criteria, recourse shall be taken to operate the lists made in terms of the following relaxed provisions. In any case no one shall be appointed from the second list for the second term as has been stipulated below:-

General Instructions regarding relaxation of provisions for residency scheme for the junior residents vide circular No. F.121/26/2010/H&FW/DSHF-1996-2045 dated 10.06.2011 issued by the Deputy Secretary (H&FW), Health & Family Welfare Department, Govt. Of NCT of Delhi are as under:-

(i) Upper age limit for eligibility will be 40 years in place of existing 30 years of age

(ii) Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if fresh graduates are not available.

(iii) Junior Residents who have completed one year of junior residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh junior residents are available. There would be no extension for any junior resident beyond one year of appointment under relaxed provisions.

OTHER INSTRUCTIONS:

A. All the column in application must be filled in properly along with prescribed fee in the form of Bank Draft of Rs. 500/- for General & OBC Candidates and nil for SC/ST/PH candidates drawn in favour of **Medical Superintendent GTB Hospital " payable at New Delhi"** as incomplete applications are liable to be rejected summarily.

B. The applicants must report in the office of Medical Director, Room No. 331, IIIrd Floor, Administrative Block, GTBH on **21.08.2017 to 24.08.2017 at 09:30 A.M..**

C. Photocopies of all the required certificates duly self attested by the applicant must be attached with the application. The candidates must have their original certificates with them at the time of interview to show the Members of Selection Board if desired. Please Note that any discrepancy pertaining to the documents may invite cancellation of offer of appointment as well as it may lead to legal action under the relevant provisions of Indian Penal Code(IPC).

(a) Date of Birth certificate(X-standard passing board certificate)(b) The Candidates shall provide Delhi Medical Council Registration certificate/ "Applied for" receipt at the time of Joining. The applied for candidate must submit DMC registration within 45 days of Joining otherwise his/her appointment shall be cancelled (c)MBBS Certificate alongwith mark sheets(d) Attempt Certificate (e) Internship completion certificate (f) Caste certificate (g) Experience certificates, if any (h) Aadhar Card & proof of Permanent Address.

E. OBC Candidates of Delhi state are only eligible for reservation and required to submit their caste certificate (issued on or before the date of interview) by the Competent Authority of GNCT of Delhi.

F. SC/ST certificate issued from the Judicial/Revenue-Authorities as per Notice in M.H.A O.M No. 42/21/49-NGS dt. 28.01.1952 as Revised by the Deptt. Of pension & A.R Letter No. 36012/6/71-Estt.(SCT) Dated 29.10.77 shall be accepted.

G. List of the selected candidates will be displayed on notice board and website of Health & Family Welfare department.

- H. Appointment will be subjected to medical fitness and verification of all the relevant certificates of education qualification/age/caste/DMC registration certificates etc.
- I. The selected candidates will report for duty with in the period of 07 days from the date of issue of offer of appointment.
- J. The selected Junior Resident can be posted in any of the department as per requirement.
- K. Any type of discrepancy may invite cancellation of appointment and legal action as per the rules.
- L. No TA/DA will be paid for the interview.
