On the basis of marks scored in written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, **No Candidate found suitable** to the post of Junior Engineer (Civil) under post code 06/12 as per conditions of eligibility criteria and also the information furnished by the candidates in online application form.
