NOTIFICATION

Subject :- Revised Water Tariff w.e.f. 01.02.2018.

Delhi Jal Board (DJB) in exercise of powers conferred under Section 55 of the Delhi Water Board Act, 1998 vide Resolution No. 512 dated 26.12.2017 has approved to enhance water & sewer rates @ 20% in respect of all the consumers w.e.f. 1st February, 2018 i.e. from Billing Round 6/2017-18 onwards. However, Service Charges will remain unchanged. The Domestic Consumers will continue to avail the benefit of existing 20 KL Free Water Scheme.


Accordingly, revised tariff w.e.f. 01.02.2018 will be as under:-
