- 1 Qualification:-BDS Degree from a recognized university/Institute.
- 2 Registration: The Candidates must be registered/applied with Delhi Dental Council.
- 3 Candidates who have completed internship before two year from last date Submission of application are not eligible(**10 .04.2015**)
- 4 Admissible emoluments: Pay Band Rs.15600-39100/- plus Grade Pay Rs.5400/- and other allowances as admissible under the rules.
- 5 Age limit as on Last date of submission of application:-
SC/ST- 35 Years
OBC- 33 Years
General- 30 years.
Age relaxation for the SC/ST/OBC/Divyang candidates shall be applicable as per instructions of Govt. of India from time to time.
- 6.**Tenure : Initially appointment is for 6 month tenure which will be extended up to 1 Year after due recommendation by the concerned HOD.**
7. The number of post may vary as per requirement.
8. In case number of applications are high, the interview/examination may be continued on the next working days. The same will be informed to the candidates verbally by Board Members on the date of interview at the closing time. Therefore, candidate who is not interviewed/appeared in examination on the said date shall not leave the place, without the knowledge of Board Members.
