Walk-in- interview for the post of Junior Resident (MBBS) on Adhoc & Emergent basis initially for a period of 44 days or till regular incumbent joins whichever is earlier.

Note: The number of post may vary as per requirement. In case number of applications are very high, the test/interview may be continued on the next working days. The same will be informed to the candidates verbally by Board Members on the date of interview at the closing time. Therefore, candidate who is not interviewed on the said date shall not leave the place of interview, without the knowledge of Board Members. No separate communication will be made in this regard.

Criteria of Eligibility:-

1 Junior Residents(MBBS):-

- (a) Qualification:-MBBS passed from a recognized university/Institute. Candidate must have not completed one year Junior Residency from any Govt. Hospital/Institute.
- (b) Registration: The Candidates shall provide Delhi Medical Council Registration certificate/ Applied for receipt at the time of Joining. The applied for candidate must submit DMC registration within 45 days of Joining otherwise his/her appointment shall be cancelled.
- (C) Tenure :- JRs are appointed for maximum period of One Year including previous experience, if any. However, initial appointment is made for 44 days extendable for upto One year with mandatory break of one day after every 44 days on the basis of satisfactory work & conduct report from the concerned HOD on request from the doctor concerned or till regular incumbents joins whichever is earlier. However, this is subject to the condition that only those candidates shall be considered for residency who have completed their internship within 2 years from the date of filling up the posts.
- (d) Admissible emoluments:) Admissible emoluments: Pay level 10 Rs. 56100 + NPA and other allowances as admissible under the rules. Leave – 1 ½ days paid leave for 44 days.
- (e) Age limit on the date of interview. General- 30 years, SC/ST-35 Years, and 33 Years for OBC(belonging to Delhi only). Age relaxation for the SC/ST/OBC/PH candidates shall be applicable as per instruction from Govt. of India time to time. General Instructions regarding relaxation of provisions for residency scheme for the junior residents vide circular No. F.121/26/2010/H&FW/DSHF-1996-2045 dated 10.06.2011 issued by the Deputy Secretary (H&FW), Health & Family Welfare Department, Govt. Of NCT of Delhi are as under:-
1. Upper age limit for eligibility will be 40 years in place of existing 30 years of age
 2. Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if fresh graduates are not available.
 3. Junior Residents who have completed one year of junior residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh junior residents are available. There would be no extension for any junior resident beyond one year of appointment under relaxed provisions.

"It is worth mentioning that earlier relaxation provisions regarding residency scheme for the junior residents have been taken in respect of under graduate, however, this will be first time to offer relaxation of provisions to post graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if fresh graduate are not available."

Further, it has been clarified that aforesaid provisions made in relaxation of the provisions of the Residency scheme are only the enabling provisions. In the first place the recruitment has to be made strictly as per the Residency Scheme as circulated by the Ministry of Health & Family Welfare. In case of non-availability of the candidates as per the relevant scheme, recourse shall be taken to operate the lists made in terms of the aforesaid relaxed provisions. In any case no one shall be appointed from the second list for the second term as has been stipulated above.

OTHER INSTRUCTIONS:-

1. All the column in application must be filled properly as incomplete applications are liable to be rejected summarily.
- (2)The applicant must report in Room No. 331, IIIrd Floor, Administrative Block, GTBH on **24.04.2018 between 09:30 to 11:30 am for registration.**
- (3) All the required certificates duly self attested by the applicant must be attached with the application. The candidates must have their original certificates with them at the time of test/interview to show the Members of Selection Board if they desired so. *Please Note that any discrepancy pertaining to the documents may invite cancellation of offer of appointment as well as legal action under the relevant provisions of Indian Penal Code(IPC).
- (4) Enclosures as mentioned here under are to be attached with the applications: (a) Date of Birth certificate(X-standard)(b)Delhi Medical Council registration (c)MBBS Certificate alongwith mark sheets(e) Attempt Certificate (f) Internship completion certificate(g) Degree of MBBS (h) Caste certificate (i) Experience certificates, if any
5. OBC Candidates of Delhi state are only eligible for reservation and required to submit their caste certificate (issued on or before the date of interview) by the Competent Authority of GNCT of Delhi.
6. SC/ST certificate issued from the Judicial/Revenue-Authorities as per Notice in M.H.A O.M No. 42/21/49-NGS dt. 28.01.1952 as Revised by the Deptt. Of pension & A.R Letter No. 36012/6/71-Estt.(SCT) Dated 29.10.77 shall be accepted.
7. Physically disabled candidates will be eligible for reservation in the concerned category as per Rules of Govt. of India
8. List of the selected candidates will be displayed on notice board.
9. The selected candidates will report for verification of original documents as well as medical examination within the period of 07 days from the date of issue of offer of appointment. No joining will be allowed without medical fitness report from staff physician, GTBH. Candidature may be cancelled in case of non compliance for reporting in prescribed time.
10. Any type of discrepancy may invite cancellation of appointment and legal action as per the rules.
