
NOTICE

The District Magistrate(North-West) invites quotations for Topographical/TSM Survey with demarcation alongwith Sketch (Hard & Soft) in Distt. North-West. Interested Agencies/Vendor/Service Provider are hereby requested to submit their quotation in O/o District Magistrate (North-West), Caretaking Branch, Room No. 15, DC office Complex Kanjhawala, Delhi-110081, on or before 19.06.2018 at 3.00 PM. The Details of work to be carried out are as under:-

1. Topographical TSM Survey with demarcation alongwith sketch (hard & soft)
2. Marking demarcation so conducted.

Term & Conditions:-

1. The Agencies/Vendor/Service Provider shall truly and faithfully carry out the said job in proper manner/standard fashion/latest technology for demarcation.
2. The Agencies/Vendor/Service Provider should participate on the basis of per day.
3. Only registered companies/firms, Partnership, proprietor ship having GST No., PAN No. Registration No. etc will be participated otherwise bid will be summarily rejected.
4. If the work is not completed within time the Deptt. Will have option to replace the vendor/service provider to get the work completed and the cost and expenditure incurred therein shall be recoverable from the second party i.e service provider.
5. The Agencies/Vendor/Service Provider shall deposit Bid Security (Earnest Money Deposit) for an amount of Rs. 10000/- in the form of an Account Payee DD, Fixed Deposit Receipt from a commercial bank, or Bank Guarantee from a commercial bank in an acceptable form in favour of **DDO, DC (North West) Kanjhawala** along with the Tender document. The Bid Security will remain valid for a period of forty-five days beyond the final bid validity period. Bid securities of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract.
6. The vendor/Service provider will ensure for Topographical/TSM Survey with demarcation alongwith Sketch (Hard & Soft) failing which a penalty as proposed by the Department (Office of the District Magistrate (North-West), Kanjhawala, Delhi-110081) will be imposed. However, before imposing penalty, the Department will issue a show cause notice in which the details of downtime will be mentioned. It will also include the penalty proposed to be imposed on the vendor. The O/o Deputy Commissioner, North West District, Government of NCT of Delhi, is not bound to accept the lowest or any bid and may at any time terminate the tendering process without assigning any reason.
7. Even after completion of work vendor may have to visit this office in case any discrepancies is noticed Or any correction is required.
8. The O/o Deputy Commissioner, North West District, Government of NCT of Delhi, may terminate the contract if it is found that the agency is black listed on previous occasions by the any of the Departments/Institutions/Local Bodies/Municipalities/Public Sector Undertakings, etc.
9. The Department of O/o Deputy Commissioner, North West, Kanjhawala, Delhi, Government of NCT of Delhi, may reject the Bid in the event that the Bid is accepted but the successful bidder fails to furnish the Performance.
