**NOTICE**

The department intends to issue 04( Four) temporary license for running Fair Price Shops in Rajouri Garden under Circle -27 keeping in view in the interest of the beneficiaries in the below mentioned Notified Area:

1. Temporary license shall be valid only for a period of three months from the date of issue and shall not be renewed.
2. Eligibility for grant of temporary license the eligibility criteria for grant of temporary license including age and educational qualification shall be the same as that for regular license . However, in case of dimensions of the shop, relaxation may be granted by the competent authority liberally depending upon the number of ration cards prepare to be attached to the proposed temporary FPS.
3. Temporary license shall be granted only to a person who resides in the same Revenue Distt in which the FPS is proposed to be located.
4. While granted temporary license, old KOD licensee persons belonging to SC/ST, Women self help groups, Ex-Service men and handi-capped persons shall be given preference . As it is purely a temporary , emergent measure /reservations will not apply.
5. A person who has been convicted of an offence under the Essential Commodities Act-1955 or any other offence under the Indian Penal Court or any other Law Enforcement in India, Shall not be granted temporary license . A Declaration to this effect from the applicant shall be sufficient for considering his case for grant of temporary license.
6. The premises of the applicant shall be inspected by the concerned FSO who will submit report to the Asstt. Commissioner concerned.
7. Based on the eligibility of the applicant , preference category and the location of the premises, the Assistant Commissioners will take decisions for grant of temporary license to persons/Groups.



8. Grant of temporary license shall not in any way entitle the licensee to get regular license. For grant of regular license the prescribed procedure shall be followed. One persons /Self help group shall not be given more than one license.
9. The applications shall be submitted in the prescribed format , alongwith the declarations attached as annexure to these guidelines .
10. Following documents shall be submitted along with application for temporary license.
  - a) Proof of Identity.
  - b) Proof of Residence.
  - c) Proof of Educational Qualification .
  - d) Proof of legal possession of the premises.
  - e) Copy of passbook/Bank statement.
  - f) Draft of security money of Rs.10,000/- per FPS.

The last date for submission of application from in the circle office is upto 20.03.19. by 5.00PM sharp.
