

OFFICE ORDER

In continuation of Office Memorandum No. F. 342/52/2006/H&FW/300012-057 dated 25-10-2007 wherein it was directed that medical reimbursement under the scheme to pensioner beneficiaries will continue to be made through concerned departments (from DGEHS Card has been issued) till the time alternative arrangements are made to reimburse the same to the pensioners directly by Directorate of Health Services).

Now, as necessary arrangement to pay the direct medical reimbursement to pensioner beneficiary has been made by providing the manpower and other required infrastructure. It is notified that reimbursement under the scheme to pensioner beneficiaries except retired high court judges, ex MLAs, will be made directly by DGEHS for which the funds have already been allocated under the head A. (1)(4)(1)(9)-non-plan Delhi Government Employees Health Scheme – Medical facilities to the Pensioners.
