**[2] ELIGIBILITY FOR THE POST OF JUNIOR RESIDENT [DENTAL]**

- 1. Qualifications:-**BDS degree from recognized university/institute. Attested copy of BDS Degree/provisional Certificate & Marks sheets of all four years to be attached. Must not have completed 06 months Jr. Residency in any Government institution.
- 2. Age limit :-**As on 29.09.2014 shall be 40 years for General candidates, 45 years in case of SC/ST and 43 years in case of OBC candidates in accordance of circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi. Attested copy of age proof (Class 10<sup>th</sup> certificate) to be attached.
- 3. Pay Scale:-**Pay Band-3 plus GP Rs. 5400 and other admissible allowances per month.
- 4. Internship:-**Candidates must have completed their internship and the candidates having completed compulsory rotatory internship before **28/09/2012** shall not be eligible.

5. Must be registered with DCI/Delhi Dental Council/State Dental Council & Applied for registration receipt for the same shall also be acceptable.
