OFFICE ORDER

Subject:- Regarding enhancement of Fixed Medical Allowance to the Delhi Government Pensioners not opting/ not covered under DGEH Scheme.

In Continuation of the OM No. F.25(III)/DGEHS/140/DHS/09/38850-38862 dated 28-07-2010 and consequent of the revision of the rates of FMA by Central Govt vide O. M. No.4/25/2008-P&PW(D) dated 26th May 2010, it is hereby ordered that grant of fixed medical allowance to the pensioners of Delhi Government has been enhanced from Rs. 100/- to Rs.300/- per month w.e.f. 01-09-2008. The fixed medical allowance will be granted to the retired persons/pensioners, residing in areas not covered by the scheme. The fixed medical allowance will also be granted to retired persons only residing in the areas covered by the scheme, but who do not opt to become member of the scheme.
