Applications are invited for appointment of Senior and Junior Resident Doctor (Dental) on regular basis in this hospital. **Application duly filled should reach the office of the Medical Superintendent, Jag Pravesh Chandra Hospital, Shastri Park, Delhi-53, on or before 23rd, Jan. 2015 till 4 P.M. positively.** Application received after the closing date will not be entertained. Hospital will not be responsible for any delay in postal submission.

Application should be furnished on plain paper, duly typed, mentioning name, father's name, date of birth, category (Gen./SC/ST/OBC), Disability if any, if so, the kind of disability, permanent residential address, address for correspondence, contact telephone nos., academic qualifications, DMC Regn. No., Date of completion of internship, experience, name & address of the present employer, any other information relating to the job, along with attested copies of certificates/ testimonials and the requisite application fee. One passport size photograph should be affixed on the application form. The candidates should report for interview in the Administrative Block, Jag Pravesh Chandra Hospital as per the date and time schedule given below:-

**Note:** One post of Senior Resident is reserved for physically handicapped candidate as per horizontal reservation

**Qualification:** MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University/Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & adhoc period.

**Note:** - (a) In case of non-availability of candidate with PG Degree/Diploma, candidate with two years experience during PG Degree/Diploma in the respective specialty will be considered.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision circulated as per circular No.F.121/26/2010/H&FW/1996-2045 dated 10/6/2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxations :-

- (i) Upper age limit for eligibility under relaxation will be 40 years.
- (ii) In the specialties where there is perpetual shortage like anesthesia and radiology etc. or in specialties where no fresh candidates are available, candidates who have completed 3 years of Sr. Residency may also be allowed to appear in the interview.
- (iii) Separate merit lists for fresh candidates and for others (those who have completed 3 years of Sr. Residency already) would be prepared.
- (iv) Firstly, the list containing the names of fresh candidates would be exhausted for appointment as Senior Residents and the second list would be used only after that.
- (vi) All Senior Residents appointments from second list will be for 89 days only.

**Qualification:** BDS degree from a recognized University /Institute. Attested copy of BDS Degree / Provisional Certificate & Mark Sheets of all four years to be attached. Must not have completed six months Junior Residency in any recognized / Govt. institute / hospital including Regular or Adhoc basis. Registration: must be registered with Delhi Dental Council.

**Internship:-** Must have completed one year internship not before 2 years as on date of interview.

**Tenure:** Appointment will be initially for a period of six months.

**Pay scale:** PB-3 of Rs. 15600-39100+ Grade Pay Rs.5400 plus allowances as admissible under the rules.

**Age:** 30 years for Gen candidates on the closing date of submission of application.

**Fee Payable (Non-refundable) for SR & JR(Dental):-**

Rs. 200/- for General Candidates and Rs. 100/- for OBC in the form of **Demand Draft/Pay order, in favour of Medical Superintendent, Shastri Park Hospital, payable at Delhi.** SC, ST and Physically Handicapped candidates are exempted from payment of fee.

**Other conditions of Recruitment: -**

1. The tenure of Regular Senior Residents shall initially be for a period of one year which is extendable up to a maximum period of three years (including the previous experience as Senior Resident on adhoc or regular basis from any recognized institutions) on annual basis, subject to satisfactory work & conduct.
3. The candidates who are already in govt. service should submit an NOC from his/her employer.
4. The services shall be governed by residency schemes of Govt. of India. /Civil Services (Temporary Rules).
5. Candidates are required to bring all original certificates and testimonials with their attested photocopies along with one passport size photograph on the date of interview.
6. Candidates who are working on adhoc basis in JPCH shall have to apply afresh.
7. Appointment shall be subject to medical fitness & verification of certificates.
8. The number of vacancies may vary.
9. In case of non availability of SC/ST/OBC candidates, the post may be filled on Adhoc basis from other categories and vice-versa.
10. OBC candidates are required to submit their caste certificate (issued before the date of submission of application) by the competent authority of Govt. of NCT of Delhi.
11. No TA/DA will be paid for appearing in the interview.
12. List of candidates short listed for interview shall be displayed on the notice board on the day of interview.
