**CLARIFICATION**

**Sub: Improvement in Delhi Government Employees Health Scheme (DGEHS)**

Reference this office memo of even number dated 28-07-2010, following clarification is issued:-


1. Subscription is to be deposited at CGHS rates. For life long membership beneficiary will have to pay an amount for ten years at per CGHS rate given in following schedule as per grade pay. The subscription can also be accepted even for a period not less than 06 months (Jan to June & July to Dec). The beneficiary will get the benefit only for the period he deposits the subscription.

**Revision of Subscription:** The subscription of DGEHS has been revised on the basis of grade pay given below:-

Grade pay to the beneficiary	Subscription under CGHS per month now applicable in DGEHS Scheme
Rs. 1650	Rs. 50
Rs. 1800, 1900, 2000, 2400 and 2800	Rs. 125
Rs. 4200	Rs. 225
Rs. 4600, 4800, 5400 and 6600	Rs. 325
Rs. 7600 and above	Rs .500

2. Beneficiaries residing outside NCR shall be entitled for reimbursement for treatment even during non-emergent conditions also from Govt. and Govt. recognized hospitals.
3. All retired Delhi Govt. Pensioners shall be eligible to become members of this scheme.

The above provisions will be applicable with effect for 1<sup>st</sup> Aug.2010
