ORDER

Whereas **Holtec CGHS Ltd.**, Plot No. 2, Sector-9, Dwarka, New Delhi-110077 is registered vide Registration No. 683-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Vide letter dated 09/09/2025, the President of the society requested this office to appoint a Returning Officer to conduct the election of the M.C of the society u/s 35(1) of DCS Act, 2003 whose term will expire on 09.10.2025.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) O/o RCS, hereby convey the approval of the Competent Authority to appoint Sh.
