ORDER

Whereas **The IFCI Employees CGHS LTD.**, Plot No. 4, Sector-23, Dwarka Phase-I, New Delhi-110077 is registered vide Registration No. 633-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, an agenda notice dated 12/09/2025 was received from Sh. Balbir Singh Yadav (who was appointed Returning Officer said society on 07/09/2025) to hold election for the Managing Committee of the said society. However, no information of resignation of the Managing Committee of the society has been received in this office, although the last election was held on 14/04/2024.

In this regard, M.C of society has failed to comply with the DCS Act, 2003 and Rules, 2007 (as per Schedule-II) and the violation/shortcomings are as under:-

- (i) The M.C of society failed to meet at least sixty clear days in advance of the date of expiration of its present term and by resolution determine the date, time and place for convening a general body meeting for conduct of election of its successor Committee.
- (ii) The M.C of society failed to prepare a list of members as it stood on thirty days before the date fixed for the inviting nomination, and publish copies of the said list by affixing them upon the Notice Board.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Praveen Solanki, Section Officer, GNCTD as Administrator-cum-RO in the IFCI Employees CGHS LTD., Plot No. 4, Sector-23, Dwarka Phase-I, New Delhi-110077 under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration & conveyance from the society funds for this purpose.

This issues with the prior approval of Worthy RCS.
