ORDER

Whereas Indian Bank Staff CGHS LTD., Plot No. 32, Sector-6, Dwarka, New Delhi-110075 registered vide Registration No. 613/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Vide letter dated 24/07/2025, Sh. Sumit, Section officer was appointed as Returning Officer thereafter he had joined the society on 02/08/2025 and requested to MC to provide all documents required for conducting the elections within a week. Later he visited the society on 17/08/2025 and written letter dated 17/08/2025 & its subsequent reminders dated 30/08/2025 & 06/09/2025 to President/Secretary of society to submit the documents/records related to election. But, no response has been received from MC of society. Thereafter, the manager of the society provided the documents on 11/09/2025.

The term of the present MC of society has been expired on 17/09/2025 thereafter the society no longer has any signed authority to manage daily operations or release funds for election expenses.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) O/o RCS, hereby convey the approval of the Competent Authority to appoint Sh. Sumit, Section Officer as Administrator-cum-RO in Indian Bank Staff CGHS LTD., Plot No. 32, Sector-6, Dwarka, New Delhi-110075 under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the issue of this order.

The Returning Officer will perform the duties of Administrator-cum-Returning Officer under section 35(5) of DCS Act, 2003 from 18.09.2025 onwards. He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration & conveyance from the society funds for this purpose.

This issues with the prior approval of Competent Authority.
