ORDER

Whereas ~~Indian~~ Indian Airlines (Cargo) Co-operative Group Housing Society Ltd., Plot No. 3-A, Sector-11, Dwarka, New Delhi - 110075 is registered vide Registration No.130-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, as per records and reports received, the audit report for the financial year 2023-2024 has not been approved in the AGM, and the audit for 2024-2025 is still pending. In absence of the mandatory approved audit reports, the election process could not be completed in accordance with the provisions of the Delhi Co-operative Societies Act, 2003 and Rules, 2007.

Further, the term of the present Managing Committee is to be expired on 19.11.2025, and a new committee could not be elected due to the above statutory deficiencies.

And whereas, in exercise of the powers vested under Section 35(5) of DCS Act, 2003, the competent Authority has approved that the affairs of the society shall be managed by an Administrator-cum-Returning Officer.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Shri Mahendra Pratap Singh is hereby appointed as Administrator of the above Society for a period of 90 (ninety) days w.e.f. 20.11.2025 to 17.02.2026 or till a duly elected Managing Committee assumes charge, whichever is earlier in Indian Airlines (Cargo) Co-operative Group Housing Society Ltd. under section 35 (5) of DCS Act, 2003.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration & conveyance from the society funds for this purpose.

This issues with the approval of the Competent Authority.
