ORDER

Whereas Sh. K.S. Meena, IAS (Retd.) was appointed as Administrator-cum-Returning Officer to manage the affairs of Indian Airlines Co-operative Group Housing Society Ltd. (Regn. No.130-GH) vide order No. F.No.47/AR/130/GH/Sec-3/RCS/2024/560-563 dated 09.08.2024 under Section 35(5) of the Delhi Co-operative Societies Act, 2003 for a period of 90 days.

His tenure was subsequently extended from time to time for facilitating the conduct of the Managing Committee election. The last extension expired on 01.11.2025.

As per Section 37(b) of the Delhi Co-operative Societies Act, 2003, the total period for which an Administrator may manage the affairs of a Co-operative Society "shall not exceed 365 days in aggregate." Since this statutory limit has been exhausted, continuation of Sh. K.S. Meena, IAS (Retd.) beyond this period is not permissible.

Now therefore, in exercise of powers under Section 35(5) of the Delhi Co-operative Societies Act, 2003, the Competent Authority is pleased to appoint Sh. Sagar Khanna, Section Officer, O/o RCS, as the Administrator-cum-Returning Officer for Indian Airlines Co-operative Group Housing Society Ltd. (Regn. No.130-GH) Plot No-7, Mayur Vihar, Phase-I, Delhi-110091 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration & conveyance from the society funds for this purpose.
