NOTICE

Subject: Filing of Annual Returns under Section 32 of the Delhi State Cooperative Societies (DCS) Act, 2003 – regarding

It is brought to the notice of all registered cooperative societies that as per the provisions of **Section 32** of the *Delhi State Cooperative Societies Act, 2003*, every society is **mandatorily required to file its Annual Returns** within **thirty (30) days** from the date of the Annual General Body Meeting.

2. The Annual Return shall contain details relating to the society's constitution, business, and allied matters, and must be filed with the office of the Registrar in the prescribed format.

3. **Non-filing of the Annual Return is an offence under the DCS Act, 2003**, and the office bearers responsible for such default shall be liable to penal action as per the provisions of the said Act.

However, it has been observed that a large number of societies have not filed their Annual Returns, in violation of the statutory provisions.

4. **In view of the above, all societies which have not yet filed their Annual Returns are hereby directed to do so immediately**, failing which appropriate action shall be initiated against the defaulting societies and their office bearers, in accordance with law.

5. This issues with the approval of the **Registrar Cooperative Societies, Delhi.**
