ORDER

Whereas, the New Kanchanjnuga CGHS Ltd. Plot No.1, Sector-23, Dwarka, New Delhi-110077 is registered with this department at Regn. Non.824(GH) under the provisions of DCS Act and Rules.

Whereas, the society has been requested to appoint the Administrator Cum R.O. due to dissolution of Managing Committee of the society for conducting fresh election of M.C. of the society. Furthermore, the society election earlier conducted on 01.02.2026. Total 09 members were elected including president and vice president and two ladies members were elected unopposed. After this dated 22/24, April, 2026 Sh.C.L.Paul, the Vice President and two members Sh.D.C.Mathur and Sh.Sanjeev Gujral resigned from the M.C. with immediate effect due to working style of some office bearers which was against the conducive and harmonious functioning of the M.C. Subsequently, two other elected members of the Managing Committee also resigned from the Society.

Whereas, as a consequence of the aforesaid resignations, only four (04) elected members remain on the Managing Committee, which is below the minimum prescribed strength required under the provisions of the Delhi Cooperative Societies Act, the Rules framed thereunder, and the Bye-laws of the Society. Consequently, the present Managing Committee has been reduced to a minority and is no longer competent to function.

Now, the undersigned is directed to convey the approval accorded by the Competent Authority i.e. Worthy Registrar Cooperative Societies, GNCT of Delhi to appoint Shri Sumit, Section Officer as an Administrator-cum-Returning Officer in New Kanchanjnuga CGHS Ltd. under Section 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and to hold the election of the Managing Committee of the society as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007 within Ninety(90) days from the date of issuing this Order. The Administrator-cum-R.O., on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/-(Rs. Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
