Now, therefore, I, Suman Kumari, Assistant Registrar (H/SEC-VII) hereby convey the approval of the Registrar Cooperative Societies to (appoint Sh. Prashant Kumar Raghav, Ex-Director, Sports Authority of India in Saptaparni CGHS Ltd.,) Plot no.04, Sector-19B, Dwarka, New Delhi-110075 under section 35(5) of Delhi Co-Operative Societies Act, 2003 to manage the day to day affairs of the society and to hold the election of the new managing committee of the society within a period of 90 days as per provisions of Rule 53 & Schedule II of the DCS Rules, 2007.
