**ORDER**

Whereas, Shri Ramdev CGHS Ltd., DB-42E, Hari Nagar, New Delhi-110064, is registered with the Department vide registration No.737/GH under the provision of DCS Act and Rules.

And whereas, a representation dated 18.07.2025 along with previous representations dated 02.01.2025 and 06.06.2025 received from the President of the society vide which it was apprised that the tenure of the managing committee has expired on 06.03.2025 and it was also requested to appoint Returning Officer to conduct the elections of the managing committee.

And whereas, the tenure of the managing committee has already been expired, now therefore, in exercise of the powers conferred by Section 35(5) of the DCS Act, 2003, the Competent Authority is pleased to appoint Sh. Naveen Kataria Retired DANICS as the Administrator cum Returning Officer to manage day to day affairs of the society and to hold the election of the Managing Committee of the aforesaid society as per provisions of DCS Act, 2003 & DCS Rules, 2007 and registered bye-laws of the society.

The managing committee of the society shall pay a consolidated amount of Rs. 10,000/- (Rs. Ten thousand only) per month for 90 days as honorarium to the Administrator along with conveyance charges and other election expenses, as applicable. The Administrator, on expiry of 90 days will not exercise any financial power till the term is further extended by the Competent Authority.

The election shall be conducted as per the guidelines prescribed in under Schedule-II Rule 53 of DCS Rules, 2007.
