ORDER

Whereas, State Bank of India Sub-staff CGHS Limited, State Bank Colony, Near Sant Nagar, Pitampura, Delhi-34 is registered with this Department vide Regn. No. 73/GH under provisions of DCS Act & DCS Rules.

Whereas communications from the President of the society wherein he has informed that there is some maintenance dispute due to which the day to day working of the society are getting suffered and there is no mutual consensus amongst the members and has further been informed that there has been no audit in the society for the last 25 years and no election have been conducted since 2021.

Whereas from the above facts, it is clear that there is no Managing Committee in existence at present and as per the provisions of Section 35(5), the Administrator in the society is required to be appointed to manage the day to day affairs in the society and to conduct elections as per Schedule II of Rule 53 of DCS Rules, 2007.

Now, therefore, I Rajeev Chhabra, Assistant Registrar (H/Sec-VII) hereby convey the approval of the Registrar Co-op. Societies to appoint Sh Soran Singh, Adhoc DANICS(Retd) GNCTD as the Administrator in the Society u/s 35(5) of DCS Act, 2003 for the period of 90 days from the date of issue of this order to manage the day to day affairs of the society as well as to conduct the election in the Society as per the provisions of Schedule 2 of Rule 53 of DCS Rules 2007.

The Administrator shall draw a sum of Rs. 10,000/- (Rs. Ten thousand only) per month as honorarium along with the conveyance charged and election expenses out of the funds of the society. Further, the Administrator, on expiry of 90 days will not exercise any financial power till the term is further extended by the Competent Authority.

This issues with the approval of the Competent Authority.
