ORDER

Whereas, Saptaparni CGHS Ltd., Plot no.04, Sector-19B, Dwarka, New Delhi-110075 is registered with the Department vide registration No. 1180/GH under the provision of DCS Act and Rules.

And whereas, vide this office order dated 21.07.2025, Sh. Prashant Kumar Raghav was appointed as Administrator in the society under section 35(5) of DCS Act, 2003. However, vide joint representation of 22 members of the society it was apprised that he has not joined as administrator in the society and shown unwillingness to take up this responsibility.

Now, therefore, I, Suman Kumari, Assistant Registrar (H/SEC-VII) hereby convey the approval of the Registrar Cooperative Societies to appoint Sh. R.S Krishnan, Adhoc-DANICS as Administrator in Saptaparni CGHS Ltd., Plot no.04, Sector-19B, Dwarka, New Delhi-110075 under section 35(5) of Delhi Co-Operative Societies Act, 2003 to manage the day to day affairs of the society and to hold the election of the new managing committee of the society within a period of 90 days as per provisions of Rule 53 & Schedule II of the DCS Rules, 2007.

The Administrator will draw a consolidated amount of Rs. 10,000/- (Rs. Ten thousand only) per month (for three months) as honorarium along with conveyance charges and other election expenses, as applicable. Further, on expiry of 90 days, he will not exercise any financial power till the term is further extended by the Competent Authority.
