ORDER

Whereas, Vishwas Nagar Evacuees' Plot Purchasers CGHS Ltd., Vishwas Apartment, Plot 6A, Sector-23, Dwarka, Delhi-110075, is registered in this office vide registration No. 2027/GH under the provisions of DCS Act/Rules.

And whereas it has been informed by Ex-President of the Vishwas Nagar Evacuees' Plot Purchasers CGHS Ltd. vide Ref No. VIS/Election/2025/133 dated 28.03.2025 that the present Managing Committee was elected on 16.02.2022 and now MC has appointed Returning Officer to conduct the MC elections on 04.05.2025 vide its resolution dated 15.02.2025.

From the said communication dated 28.03.2025, it is apparent that the Managing Committee passed the resolution on the last date of its tenure i.e. 15.02.2025, for conduct of MC Election on 04.05.2025 which is a violation of Clause 1(i) of Schedule II of DCS Rules, 2007.

Now, the competent Authority, GNCT of Delhi, in exercise of the powers vested in him under DCS Act 2003 & DCS Rules 2007 hereby appoints Sh. Vinod Mishra, Section Officer as Administrator-cum-Returning Officer in the Vishwas Nagar Evacuees' Plot Purchasers CGHS Ltd. under section 35(5) of DCS Act, 2003 to manage the affairs of the society and to conduct the election within a period of 90 days from the date of issue of this order. He is further entitled to receive Rs.10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance to be paid from the society's funds.

This issues with the prior approval of the competent authority.
