Mahesh Chand Jha as the new Administrator in the Society u/s 35(5) of DCS Act, 2003 for the period of 90 days from the date of issue of this order to take necessary action with regard to facilitate compliance of the Hon'ble High Court's directions and to expedite the disposal of the various issues of the society as well as to conduct the election in the Society

The Administrator shall draw a sum of Rs. 10,000/- (Rs. Ten thousand only) per month as honorarium along with the conveyance charged and election expenses out of the funds of the society.
