

The grant of NFSG is subject to the condition that, if there is a change in the date of eligibility in respect of above mentioned Grade-III Stenographers in future, due to deletion or addition of names in the eligibility list, they will have no claim over the date of eligibility.

The officials concerned may be allowed to exercise their options, if any, under FR 22 within one month of the issuance of the order granting the non Functional selection grade.

Further, grant of Non Functional Selection Grade is subject to the undertaking that in the event of over payment, which may be detected at later stage, the same will be recovered from their pay.

District Authorities may verify that the service particulars of the above officials, who are posted in Districts, are correct and are clear from Vigilance angle on the due date.
