ORDER

Whereas, the Manchahat Cooperative Group Housing Society Ltd, Plot No 42, Sector 10, Dwarka, New Delhi-110075 is registered vide Registration No. 1329/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas last election of the Managing Committee of the society was held on 28.05.2025 and President of the society vide letter dated 15.06.2025 has informed that five of the nine elected members have resigned from their respective posts and requested to appoint Administrator in the society as under the provision of Standard bye law 23 (1) of DCS Act, 2003 and Rules, 2007. Minimum 5 members required to run Managing Committee of Society. Sh. Dinesh Kumar (Sr. Accounts Officer) was appointed Administrator under section 35(5) of DCS Act, 2003 vide this office order dated 23.06.2025. Sh. Dinesh Kumar vide letter dated 19.09.2025 has requested to extend the term of Administrator for further 3 months.

Now therefore, the undersigned hereby convey the approval of the Competent Authority to regularise the tenure of Sh. Dinesh Kumar (Sr. Account Officer) as Administrator u/s 35(5) of DCS Act 2003 in Manchahat CGHS Ltd, from 24.09.2025 to 26.10.2025 and further extend the tenure for another 90 days with the directions to get elections conducted within stipulated time period. It is also directed to Administrator to submit the progress report of the present tenure in the Society.

.He will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.
