ORDER

Whereas, Delhi State Cooperative Union Ltd., 31, Netaji Subhas Marg, Daryaganj, New Delhi-110002 (*hereinafter referred to as "Society"*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 and rules framed thereunder.

Vide letter dated 18.03.2025, the members of the society informed that the last election of the society has been completed as per DCS Act, 2003.

Whereas, as per the record available in O/o RCS the date of last election held was on 22.05.2022.

Whereas, vide order No. 47/AR/BKG/RCS/262/2025/950-52 dated 24.04.2025, Sh. R.S. Krishnan, Dy. Secretary, has been appointed as Returning Officer in Delhi State Cooperative Union Ltd. under Section 35 (1) of DCS Act, 2003.

Whereas, Sh. R.S. Krishnan, Dy. Secretary, vide letter dated 19.05.2025 has resigned from the post of Returning Officer due to personal reasons.

Whereas the term of the managing committee of the Delhi State Cooperative Union Ltd. has already expired on 22.05.2025.

Whereas, vide order No. 47/AR/BKG/RCS/262/2025/1294 dated 03.06.2025, Sh. Shailesh Kumar, VATO, Department of Trade and Taxes, GNCTD, has been appointed as Administrator-cum-Returning Officer in Delhi State Cooperative Union Ltd. under Section 35 (5) of DCS Act, 2003.

Whereas, Sh. Shailesh Kumar, VATO, Department of Trade and Taxes, GNCTD has also resigned from the post of Returning Officer citing various reason(s).

Now, therefore, I Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the competent authority to appoint Sh. Anil Kumar Pratham, IPS (Retd.) as Administrator-cum-Returning Officer in Delhi State Cooperative Union Ltd. under section 35 (5) of DCS Act, 2003.

A sum of Rs. 10000/- (Rupees Ten Thousand Only) per month as remuneration plus conveyance allowance will be paid to him from the society's fund. The Administrator-cum-Returning Officer may hold election within a period of 90 days.

The expenses of conducting the election shall be met out from the fund of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the provisions of DCS Act & Rules.
