ORDER

Whereas Himachal Pradesh CGHS LTD., Plot No. 21, Sec-05, Dwarka, New Delhi-110075 is registered vide Registration No.1195-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Vide letter dated 23/02/2025, The Secretary of the society requested this office to appoint a Returning Officer to conduct the election of the M.C of the society u/s 35(1) of DCS Act, 2003, as the term of present management committee of Himachal Pradesh CGHS Ltd. would expire on 26th March, 2025.

Further, present M.C of society has failed to comply with the DCS Act, 2003 and Rules, 2007 (as per Schedule-II) and the violation/shortcoming is as under:-

- (i) The M.C of society failed to meet at least sixty clear days in advance of the date of expiration of its present term and by resolution determine the date, time and place for convening a general body meeting for conduct of election of its successor Committee.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Ajay Kumar Kaushal, (Retd. DANICS), GNCTD as Administrator-cum-RO in Himachal CGHS LTD., Plot No. 21, Sec-5, Dwarka, New Delhi-110075 under section 35 (5) of DCS Act, 2003 to look after the day to day affairs of the society and conduct the election of the MC within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration & conveyance from the society funds for this purpose.
