ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, Ekjot Cooperative Group Housing Societies Ltd.(Regn. No. 110/GH) is registered with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society.

And whereas, the representation dated 03.06.2025 was received from Sh. Harish Chander Sethi (Ex. Vice President) wherein it is informed that there is no elected Managing Committee since long and requested to depute any representative for take over the charge of the society records and arrange for conducting the MC election of the society.

And whereas, the Registrar Co-operative societies has considered the matter and approved for the appointment of Sh. Rajender Babu Shukla, Retd. Section Officer (Grade-I DASS) as Administrative –Cum-Returning Officer under Section 35(5) of DCS Act, 2003 in Ekjot Co-operative Society Ltd. with immediate effect. A remuneration of 10,000/-(Rupees Ten Thousand Only) per month and Travelling Allowance applicable shall be paid from the fund of the society and to hold the election of the Management Committee of the Society stipulated period 90 days from the date of appointment as Administrator-cum-Returning Officer.

The Ex-Vice President Management Committee of Ekjot CGHS Ltd. is hereby directed to handover the charge of the record of the Society/relevant documents to the Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
