ORDER

Whereas, the Kangra Adarsh CGHS Ltd., K-377A, Kangra Niketan, Vikaspuri, Delhi-110018, registered vide Registration No. 33/GH with this department under the provision of DCS Act. 2003 and Rules 2007 framed there under and registered Bye-Laws of the society.

Whereas, Sh. Gulshan Ahuja (BDO, Najafgarh) was appointed as Inquiry Officer under section 62 of DCS Act, 2003 vide this office order dated 10.11.2025.

Whereas, Secretary of Society vide his letter dated 19.02.2026 has informed that Inquiry Officer i.e. Sh. Gulshan Ahuja has not visited the society to initiate the inquiry proceedings and requested this office to appoint alternate inquiry officer to conduct the investigation at the earliest.

Whereas, this office vide letter dated 09.04.2026 requested Sh. Gulshan Ahuja to submit the status report of inquiry in the matters of Kangra Adarsh CGHS Ltd. Sh. Gulshan Ahuja vide letter dated 24.04.2026 has informed that he is looking after the charge of ERO AC-37 Palam and not able to conduct this inquiry and requested to give the inquiry to some other officer.

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. Pradeep Kumar (Superintendent, Prison), as Inquiry Officer u/s 62 of DCS Act 2003 to conduct the detailed investigation on the violations observed by Inspecting Officer during inspection u/s 61 in the matters of Kangra Adarsh CGHS Ltd., within 90 days.

He will be paid Rs. 10,000/- (Rs. Ten Thousand Only) as honorarium from the society fund for this purpose.
