**ORDER**

Whereas, the K.K. CGHS Ltd., Plot No.4, Sector-9, Dwarka-1, Delhi-77 registered vide Registration No. 610/GH under the provision of DCS Act, 2003 and Rules 2007 framed there under and registered Bye-Laws of the society.

Whereas, Sh. Sanjeev Khurana, AO (Prison Department), O/o Director General of Prison was appointed as Inspection Officer u/s 61 of DCS Act 2003 in K.K. CGHS Ltd. to conduct an inquiry in K.K. CGHS Ltd vide order dated 29.08.2022 in reference to the complaint filed by 54 members of the K.K CGHS Ltd., regarding allegation on the then Administrator i.e. Ravinder Sadhu, Deputy Director.

Whereas, Sh. Sanjeev Khurana has submitted its inspection report to this office with the conclusion that there is material on record to further investigate the complaint as per DCS Act, 2003 and circular/instructions issued from time to time by the RCS office.

Whereas, Sh. Ajay Arora, Deputy Director (AR), Department of Administrative Reforms, was appointed Inquiry Officer in the matter u/s 62 of the DCS Act, 2003, to conduct an inquiry but as the per information received from the AR Department vide letter dated 07/05/2026 the officer has retired from the government service.

Now, therefore, in exercise of the powers vested u/s 62 of DCS Act, 2003, the Competent Authority has approved to appoint Sh. Manmeet Singh Walia, Joint Secretary (LJ & LA) as an Inquiry Officer u/s 62 of DCS Act 2003 to conduct an inquiry regarding allegation on the then Administrator i.e Ravinder Sadhu, Deputy Director. This inquiry has to be completed within 60 days of his appointment. He will be paid Rs. 15000/- as a cost of inquiry from the society fund.
