ORDER

Whereas, Tehsil Alipur Biradari CGHS Ltd., Plot no-35, Sector-9, Rohini, Delhi-110085 is registered in this office vide registration No. 458/GH under the provisions of DCS Act/Rules.

Whereas, Sh. Rakesh Kohli was appointed as an Administrator-cum-Returning Officer vide this office order no. F 47/458/GH/Sec-8/2024/1695-97 dated 18.12.2025 u/s 35(5) for a period of 90 days in Tehsil Alipur Biradari CGHS Ltd. His tenure was to be expired on 17.03.2026. After the completion of his tenure he neither sent any status report nor any extension letter. And now he has resigned vide his letter dated 24.04.2026 citing that he is not able to continue the charge due to ill health of his wife.

Now, the competent Authority, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, hereby appoints Sh. Mahendra Pratap Singh, AD (Retd.) as an Administrator-cum-Returning Officer, in the Tehsil Alipur Biradari CGHS Ltd., under section 35(5) of DCS Act, 2003 to manage the affairs of the society and to conduct the election within a period of 90 days from the date of issue of this order. He is further entitled to receive Rs.10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance to be paid from the society's funds.

Further, the competent Authority, GNCT of Delhi in exercise of powers vested in him under DCS Act 2003 & Rules 2007 also regularize the period of Sh. Rakesh Kohli w.e.f. 18.03.2026 to 23.04.2026.

This issues with the prior approval of the competent authority.
