Administrator cum Returning Officer will be paid Rs. 10,000/- (Ten Thousand Only) per month as honorarium plus conveyance charges from the society's fund.

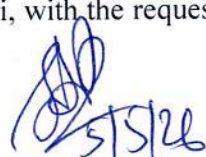
