ORDER

Whereas, Youngsters CGHS Ltd., Plot No. 13-C, Sec-06, Dwarka Phase-I, New Delhi-110075, is registered in this office vide registration No. 1352/GH under the provisions of DCS Act/Rules.

Whereas, Sh. Prahlad Singh, Sr. AO (Retd.) was appointed as Administrator-cum-Returning Officer, in the Youngsters CGHS Ltd., under section 35(5) of DCS Act, 2003 to manage the affairs of the society and to conduct the election within a period of 90 days vide this office order No. F.No.47/1352/Sec-8/GH/2024/1129-31 dated 19.09.2024.

Whereas, the tenure of Sh. Prahlad Singh, Sr. AO (Retd.) as Administrator cum Returning Officer of Youngster CGHS Ltd. expired on 17.12.2024 and no extension has been granted by this office for the extension of tenure beyond 17.12.2024 to Sh. Prahlad Singh, Sr. AO (Retd.) as Administrator cum RO of the Youngster CGHS Ltd. So he has no locus standi to manage the affairs of the Society and to conduct the election of Managing Committee of the Society after the expiry of his tenure as Administrator cum RO of the Youngster CGHS Ltd. on 17.12.2024.

Whereas, Sh. Prahlad Singh, Sr. AO (Retd.) has never submitted any status report on the affairs of the Society in this Office nor has he submitted any Agenda Notice for conducting Election in the Society, the purpose for which he was appointed as Administrator cum Returning Officer. Moreover, he has never made any request for extension of his tenure as Administrator cum RO of the Society citing the reasons for non conduction of Election of the Society.

Whereas, a representation dated 07.07.2025 has been submitted in this office by a couple of members of the Society enclosing therein a copy of Agenda Notice (front page only) for Election of MC of the Society. Complete copy of the Agenda Notice having NIL date (obtained from the members who have submitted the aforesaid representation) issued by Sh. Prahlad Singh, Sr. AO (Retd.), the Election process started on 05.07.2025 and the polling for election of the MC of the Society is scheduled to be held on 13.07.2025.

Whereas, the tenure of Sh. Prahlad Singh, Sr. AO (Retd.) as Administrator cum Returning Officer of the Society has expired on 17.12.2024, he has no authority under the Law to issue any such Agenda Notice and is bad in the eyes of the law.

So, the aforesaid Agenda Notice issued by Sh. Prahlad Singh, Sr. AO (Retd.) is hereby quashed and the Election process so initiated vide aforesaid Agenda notice is terminated with immediate effect.

This issues with the prior approval of the competent authority.
