**ORDER**

Whereas, the Ministry of Works Housing & Supply Cooperative House Building Society Ltd. Nirman Vihar, Delhi-110092 is registered vide Registration No. 1823/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Whereas, Sh. P.R. Meena, Retd. IAS was appointed as an Administrator-cum-RO vide this office order no. F.No.107786090/RCS/S-IV/2024/1966 dated 12/11/2024 u/s 35(5) of DCS Act 2003 in the society for 90 days.

And whereas, P.R. Meena, Retd. IAS has informed that he has not joined as Administrator in the society and further not interested in joining as Administrator in the society.

Whereas, in view of provisions contained in Sec 35(5) of DCS Act, 2003 an Administrator is required to be appointed to look after the day to day affairs of the society and to conduct fresh election in the society.
