SHOW CAUSE NOTICE UNDER SECTION 139 (2) OF THE DCS ACT, 2003

Whereas an appeal dated 02/09/2025 and 22/09/2025 for seeking information u/s-139 of DCS ACT, 2003 was filed by Ms. Tripta Narula, Flat No. 461, Plot no. 08, South Delhi Residents CGHS Ltd., stating that The Respondent Society has not provided the complete information and concealing relevant information in respect of RTI application filed on 15/07/2025.

And whereas hearings were conducted by First Appellant Authority on 05/02/2026 and 12/02/2026, wherein an opportunity of being heard was given to both the parties i.e. Appellant Sh. Ajay Narula Authorized representative of Ms. Tripta Narula and Advocate Sh. Anant Kumar along with Sh. Mahesh Kumar President and Ms T. Sujata Secretary of the Society. During hearing the Respondent Society agreed to provide the information to the appellant within 30 days of the receipt of order. Vide order dated 13/02/2026 the Respondent Society was directed to provide the information to the appellant.

Further, Ms. Tripta Narula filed another application for non-compliance of order dated 13/02/2026 and stating that the Respondent has provided incomplete information despite order issued by the First Appellant Authority. Thus, the Society has defied the order dated 13/02/2026 of First Appellant Authority and requested to impose penalty U/s 139 of DCS Act 2003.

And Now, Therefore, in exercise of powers vested un under the provisions of the Delhi Cooperative societies Act, 2003 & Rules 2007, it is hereby call upon the President/Secretary of the Society to why penalty be not imposed against the President/Secretary of the Society of South Delhi Residents CGHS Ltd. for not providing the requisite information. Reply of this Notice must be filed within 15 days from the receipt of this notice, failing which it will be assumed that the President/Secretary of the society has nothing to say in its defense and penalty may be imposed under the provisions of section 139(2) of DCS Act, 2003
