ORDER

Whereas, Braham Bhatt Dhan Sanchay Cooperative Urban Thrift & Credit Society Limited, C-68, Street No. 7, Ankur Enclave, Karawal Nagar, Delhi-110094 (hereinafter referred to as the Society), is registered with this Department under the provisions of the Delhi Cooperative Societies Act, 2003 (hereinafter referred to as the Act) and the Rules framed thereunder.

And whereas, vide letter dated 19.08.2025, Smt. Shiwani (Membership No. 713) submitted a representation in this regard, and accordingly a letter was issued to the President/Secretary of the Society requesting the following documents:

1. Copy of the last election proceedings;
2. Copy of the minutes of the last AGM;
3. Copy of the last statutory audit report;
4. List of members whose dues are pending along with the reasons thereof.

However, the Society has failed to submit the requisite documents/reply. Therefore, this Department has decided to appoint an Administrator/Returning Officer for conducting the elections of the Society.

Whereas, section 35(3) of the Delhi Cooperative Societies Act, 2003 states that the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election within days from the date of his appointment.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri Dinesh Kumar, Senior Account Officer, as Administrator-cum Returning Officer of the Society, in term of section 35(5) of DCS Act, 2003. A sum of Rs. 10,000/- (Rupees Ten Thousand Only/-) per month as remuneration plus conveyance allowance will be paid to him from the society's fund. The Returning Officer may hold election within a period of 90 days;

The expenses for conducting the election shall be met out from the fund of the Society. The election of MC of the Society shall be conducted as per the provisions of the Act read with rules and bye-laws framed thereunder;

This issues with the prior approval of the Competent Authority.
