ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, Entrepreneurs Cooperative Group Housing Societies Ltd. (Regn. No. 1315/GH) is registered with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society.

And whereas, the representation dated 13.06.2025 was received from Secretary (Outgoing MC) of the society wherein it is informed that election of the new Managing Committee was due in the month of 20 February, 2025 but due to heart ailment of the Vice President who had been holding the office of President due to the Resignation of President of Society, the election process could not be initiated and it got delayed.

And whereas, the Registrar Co-operative societies has considered the matter and approved for the appointment of Sh. Vijay Kumar as Administrative –Cum-Returning Officer (Ex Director General, Special Secretary Ministry of Statistics & Program Implementation GOI), under Section 35(5) of DCS Act, 2003 in Entrepreneurs Co-operative Society Ltd. with immediate effect as the Management Committee already expired on month of February, 2025. A remuneration of 10,000/- (Rupees Ten Thousand Only) per month and Travelling Allowance applicable shall be paid from the fund of the society and to hold the election of the Management Committee of the Society stipulated period 90 days from the date of appointment as Administrator-cum-Returning Officer.

The Ex- Management Committee of Entrepreneurs CGHS Ltd. is hereby directed to handover the charge of the record of the Society/relevant documents to the Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
