**ORDER**

Whereas, Vimal CGHS Ltd., Plot No. 03, Sec-12, Dwarka, New Delhi-110078, is registered in this office vide registration No. 1281/GH under the provisions of DCS Act/Rules.

Whereas, Mrs. Neelam, President and Mrs. Rita Gulia, Vice-President have resigned from the Managing Committee of the Society, resultantly the present Managing Committee reduced to only 04 members and thus unable to run the affairs of the Society as per the provisions contained in DCS Act, 2003 and Rules, 2007 & registered Bye-laws of the Society.

Whereas, in view of provisions contained in Sec 35 (5) of DCS Act, 2003 an Administrator is required to be appointed to look after the day to day affairs of the Society and to conduct fresh election in the Society.

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. Dinesh Kumar, Sr. Account Officer as Administrator U/s 35 (5) of the DCS Act, 2003 in the Vimal CGHS Ltd. with immediate effect for 90 days to look after the day to day affairs of the Society and to conduct Elections of the new Managing Committee of the Society. He will also submit a regular monthly status report of the society to this office.

He will be paid Rs. 10,000/- (Rupees Ten Thousand Only) per month as honorarium and conveyance charges from the Society fund for this purpose.

This issues with the prior approval of the competent authority.
