**Subject: Revision of rates of Dearness Allowance to the employees, who are continuing to draw their pay in the pay scale as per 5<sup>th</sup> Central Pay Commission.**

The undersigned is directed to refer to this Department's O.M. No. 1/6(2)/2024-E.II(B) dated 7<sup>th</sup> November 2024 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees, who are continuing to draw their pay in the pre-revised pay scale as per 5<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 455% to **466%** of Basic Pay **w.e.f. 01.01.2025**.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(13)/97-E.II(B) dated 3<sup>rd</sup> October, 1997 shall continue to be applicable while regulating Dearness Allowance under these orders.

3. The contents of this Office Memorandum may also be brought to the notice of all organisations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.

The undersigned is directed to refer to this Department's O.M. No. 1/6(1)/2024 -E.II(B) dated 7<sup>th</sup> November, 2024 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees, who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 246% to **252%** of Basic Pay w.e.f. **01.01.2025**

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(3)/2008-E.II(B) dated 29<sup>th</sup> August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.

**OFFICE MEMORANDUM**

**Subject: Revision of rates of Dearness Allowance to Central Government employees-  
effective from 01.01.2025.**

The undersigned is directed to refer to this Department's Office Memorandum No. 1/5/2024-E.II(B) dated 21<sup>st</sup> October, 2024 on the subject mentioned above and to say that the President is pleased to decide that the rates of Dearness Allowance payable to Central Government employees, shall be enhanced from 53% to 55% of the Basic Pay with effect from 1<sup>st</sup> January, 2025.

2. The term Basic Pay in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix as per 7<sup>th</sup> CPC recommendations accepted by the Government, but does not include any other type of pay like special pay, etc.
3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
5. The payment of arrears of Dearness Allowance shall not be made before the date of disbursement of salary of March, 2025.
6. These orders shall also apply to the civilian employees paid from the Defence Services Estimates and the expenditure will be chargeable to the relevant head of the Defence Services Estimates. In respect of Armed Forces personnel and Railway employees, separate orders will be issued by the Ministry of Defence and Ministry of Railways, respectively.
7. In so far as the persons serving in the Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under clause (5) of Article 148 of the Constitution of India.
