ORDER

Whereas, Delhi State Cooperative Union Limited, 46-Brij Mohan Marg, Darya Ganj, New Delhi-110002 (*hereinafter referred to as "the Society"*) is a cooperative society registered with this Department under the provisions of the Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as "the Act"*) and the rules framed thereunder;

And whereas, vide this Department's Order No. F.47/AR/BKG/RCS/262/2025/1900 dated 07.07.2025, Shri Anil Kumar Pratham, IPS (Retd.), was appointed as Administrator-cum-Returning Officer of the Society under Section 35(5) of the Act;

And whereas, the Hon'ble High Court of Delhi, vide order dated 13.08.2025 passed in W.P.(C) 12224/2025, has quashed the said order to the extent of appointment of Administrator, while sustaining the appointment of Returning Officer, and has further directed that the Returning Officer shall take all necessary steps to conclude the elections of the Society strictly in accordance with the time schedule prescribed by the Registrar Cooperative Societies;

And whereas, the tenure of Shri Anil Kumar Pratham, Returning Officer, has since expired on 04.10.2025, necessitating appointment of a new Returning Officer for completion of the election process;

Now, therefore, in exercise of the powers conferred under Section 35(1) of the Delhi Cooperative Societies Act, 2003, and with the prior approval of the Competent Authority, the undersigned hereby appoints Shri Ram Naresh, Custom Superintendent, as Returning Officer of Delhi State Cooperative Union Limited for the purpose of conducting elections to the Managing Committee of the Society.

The Returning Officer shall complete the entire election process within a period of ninety (90) days from the date of assumption of charge, strictly in compliance with the provisions of the Delhi Cooperative Societies Act, 2003, the Delhi Cooperative Societies Rules, 2007, and the election guidelines prescribed under Rule 53 read with Schedule-II of the said Rules. The remuneration payable to the Returning Officer shall be ₹10,000/- (Rupees Ten Thousand only), to be paid from the funds of the Society.

→ All expenses incidental to the conduct of elections shall be borne by the Society. The Managing Committee elections of the Society shall be conducted in a free, fair, and transparent manner, without interference from any individual or authority, except as permitted under law.

The General Secretary of the Society shall extend full cooperation and provide all requisite records, documents, infrastructure, and logistical support to the Returning Officer to enable smooth and timely conduct of elections.

This order issues with the prior approval of the Competent Authority.
