ORDER

Whereas, the Dera Ghazi Khan CHBS Ltd., 119, Bannu Enclave, Pitam Pura, Delhi-110034 is registered with this Department vide Regn. No. 178 (GH) under the provisions of DCS Act and Rules.

And whereas, the members of the Society vide letter dated 02.04.2026 has informed this Office that the term of the last managing committee has already expired long back. Despite the best efforts, even by holding the elections in the month of December 2025, no fresh managing committee could be constituted, as no member is willing or physically capable of taking up such responsibility. The Election Officer, who had announced and gone through the duly prescribed process of holding the elections in the month of December of 2025, has reported that none of the existing members of this society approached him, even to collect the nomination forms for any of the posts of the managing committee.

And whereas, the members further informed that in the meeting held on 29.03.2026 (Sunday), it was decided by the members present that there being no physically capable person/member to handle the management affairs of the society, the said society be handed over to the RCS after taking the consent of the willing members.

And whereas, the members of the society have requested this Office that an Administrator may kindly be appointed at the earliest to take over and manage the affairs of the Society. Necessary directions may be issued to ensure proper maintenance of records and compliance with statutory provisions, and the appointed Administrator may be also be authorized to represent the society in the pending matter before the Hon'ble High Court of Delhi and take necessary steps as per law.

Now, therefore, the Registrar, Co-operatives Societies Department, GNCT of Delhi in exercise of the power vested in him under DCS Act & Rules, is pleased to appoint **Sh. Praveen Solanki, Section Officer (Grade-I)**, for 180 days as an Administrator-cum-Returning Officer of the Dera Ghazi Khan CHBS Ltd., 119, Bannu Enclave, Pitam Pura, Delhi-110034, U/s 37(1) of DCS Act, 2003, to manage the affairs of the society and to conduct the election of the Managing Committee of the said society as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007. The Administrator-cum-R.O., on expiry of the period of 180 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/-(Rupees Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
