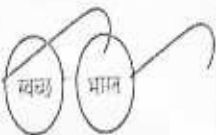

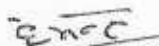

The objections/suggestions received within the prescribed period shall be examined before finalization of the proposed amendments.

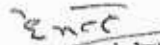
