ORDER

This order shall dispose of the proposal of the society dated 11.07.2021 for expulsion of the Ms. Vandana Sikka of the society under section 86 of the DCS Act, 2003 read with rule 99 of the DCS Rules, 2007.

Whereas, an application dated 28.04.2022, u/s 86 of DCS Act, 2003 r/w rule 99 of DCS Rules, 2007 was filed by the Managing Committee of the society for approval of expulsion of Ms. Vandana Sikka on account of persistent defaulters.

The notices were issued to the parties for the hearing dated 25.03.2022 by the Spl. RCS. On proceeding dated 25.03.2022 before the Spl. RCS, Sh. Sushil Kumar Gupta President of the society, Sh. Ashok Jain (Secretary) of the society, Saurabh Almal (Treasurer) were present and submitted a written submission filed by the society.

On 07.05.2024, the matter was heard before the undersigned. Sh. Sushil Kumar Gupta, President of the Society, was present, while no one appeared on behalf of the respondent, Ms. Vandana Sikka. The President informed that the society had made several attempts to serve notice to Ms. Sikka but was unable to trace her current address. It was further stated that a public notice had also been published in the newspaper, but no response was received. The Society was accordingly directed to submit a written report detailing the service attempts. Meanwhile, bailiff service was ordered to be executed at the last known addresses of the respondent, namely: 1937/147, Tri Nagar, Delhi, and 52/33, Old Rajinder Nagar, Delhi.

On 23.07.2024, the matter was taken up again. Sh. Sushil Kumar Gupta appeared, but the respondent was again absent. The President submitted that the society had complied with the directions. This office (RCS) sent a bailiff to both addresses. However, as per the bailiff's report, Ms. Vandana Sikka was not found residing at either location. The President confirmed that no other address of the respondent was available with the society. In the interest of justice, the society was granted one last opportunity and directed to publish a notice in one Hindi and one English newspaper, requesting Ms. Vandana Sikka or her legal heir to contact

the office of the Registrar, Cooperative Societies, before the next date of hearing fixed for 27.08.2024.

On 27.08.2024, the matter was again listed. Sh. Sushil Kumar Gupta, President of the Society, was present, but there was no appearance on behalf of the respondent. The society submitted that notices had been published in *Hindustan* (Hindi) and *Hindustan Times* (English) on 09.08.2024, as directed. Despite this, no response or communication was received from the respondent or any of her legal heirs. In accordance with the earlier order, the matter proceeded **ex-parte**. The President reiterated that the society had followed all the procedures laid down under the DCS Act and Rules in the matter of Ms. Vandana Sikka's expulsion and requested that her expulsion be approved.

In light of the written and oral submission made by society, I am of the considered opinion that Ms. Vandana Sikka has been afforded ample opportunities to present her case. The Registrar Cooperative Society and the Society have left no stone unturned in its efforts to reach out to the respondent. Despite this, she has neither remitted the outstanding dues nor appeared before the undersigned. Notices for hearings have been duly issued since 11.03.2022, yet the respondent or her legal heir has failed to attend any of the scheduled hearings. Therefore, in the exercise of the powers conferred upon me under Section 86 of the Delhi Cooperative Societies Act, 2003, I hereby approve the expulsion of Ms. Vandana Sikka.

Ordered accordingly.
